

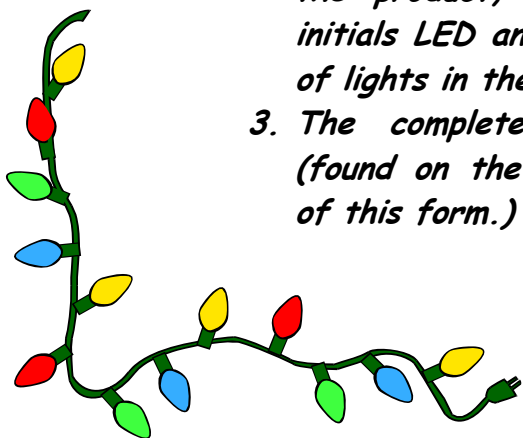


## HOLIDAY LIGHT REBATE FOR CITY OF LOMPOC CUSTOMERS

*Purchase LED holiday lights and receive a rebate of \$4 for up to 69 light strand or \$8 for a 70 or more light strand (not to exceed purchase cost) from Lompoc City Electric. Limit: rebate available for 5 strands per electric customer.*

### Lompoc City Electric Rebate for LED Holiday Lights Application

**IMPORTANT:** In order to receive a rebate for the purchase of LED (Light Emitting Diode) holiday lights, you must read and complete this application. Return to the address provided at the bottom of this application along with your receipt or a copy of your receipt and the portion of box showing the description of the product. A rebate will appear on your utility bill as a credit within two billing periods.

To be eligible for a rebate, I understand that (a) I must be an electric customer with an active electric meter serviced by the City of Lompoc and (b) I understand I must complete this Application form and provide the information requested.

In consideration of my request that the City of Lompoc provide me with a rebate for the purchase of LED holiday lights, I agree to install and operate the energy efficient lights at the address listed on this rebate Application form for a period of time no less than from December 20 to December 26 of the year of purchase.

I understand that the amount of rebate shall not exceed the purchase price of the lights and that I am limited to no more than five rebates.

I understand that if I have closed my account at the address listed above and no longer have an open account with the City before such a time that the rebate can be processed, I will forfeit any rebate due to me.

I understand that this completed and signed Application is the sole form necessary to receive a rebate for the purchase of LED holiday lights and it must be returned to Lompoc City Electric along with the receipt or copy of the receipt; portion of the box showing the product description that includes the number of lights in the strand or the word 'icicle' and the initials LED or words light emitting diode.
