CITY MANAGER REPORT: (Information only)

City Manager Patrick Wiemiller announced the Budget Priority Setting Workshop will be set for Monday, February 27, 2017; acknowledged and thanked all City employees who worked hard during the recent rain storms; and gave a brief presentation on the City's General Fund cash balance.

Management Services Director Brad Wilkie pointed out there is a typographical error on Consent Item No. 3 (exhibit D) and Item No. 4 (exhibit A) Pay Schedules, the exhibits listed are the same for both items and incorrectly list a 5% Compensation for Certification on Category 666 and should be removed from the Pay Schedules.

 - a) Accepted, approved and adopted the Tentative Agreement between the City of Lompoc (City) and the International Brotherhood of Electrical Workers Local Union 1245 (IBEW Local 1245); and
 - b) Accepted, approved and adopted Amendment No. 5 to the Memorandum of Understanding between the City and IBEW Local 1245 Effective January 1, 2015, Through June 30, 2017 (IBEW MOU 2015-17), extending the contract term of the existing IBEW MOU 2015-17 through June 30, 2019; and
 - c) Adopted Resolution No. 6092(17), which:

- c) Approved the supplemental resources to fund the supplemental appropriations to fund the compensation adjustments included the amended and restated Compensation Plans for the remainder of Fiscal Year (FY) 2016-2017.
- 4. Adoption of Resolution No. 6096(17) Affirming and Adopting a Master Pay Schedule as Required by California Public Employees' Retirement System

Adopted Resolution No. 6096(17), creating and affirming the City of Lompoc's master pay schedule for all represented employee classifications and all unrepresented employees covered by a Compensation Plan so that the City is in compliance with the requirements of the California Code of Regulations section 570.5 and the California Public Employees' Retirement System (CalPERS) relating to publically available pay schedules for purposes of determining the amount of "compensation earnable" pursuant to Government Code Sections 20630, 20636, and 20636.1.

6. Introduction of Ordinance No. 1634(17) Amending Chapter 1.08 of the Lompoc Municipal Code Relating to the City Seal and City Logo.

City Attorney Joseph W. Pannone presented the Staff report and recommendations.

<u>ACTION</u>: Motion/Second: <u>Mosby/Vega</u>. By a 5-0 vote Council introduced, by reading of the title only, and waiving further reading, Ordinance No. 1634(17), amending Chapter 1.08 of the Lompoc Municipal Code to rename that Chapter and prohibit the unauthorized use of the City of Lompoc's (City) Seal and Logo.

NEW BUSINESS:

7. Introduction of Ordinance Nos. 1632(17) and 1633(17) for the Adoption of the 2016 California Fire Code and Building Codes.

Fire Chief Kurt Latipow presented the Staff report and recommendations, and explained a minor typographical error on page 2 of Ordinance No. 1632(17) – as shown below:

SECTION 2. Section 15.12.010 of the Lompoc Municipal Code (LMC) is hereby amended, in its entirety, to read as follows:

15.12.010 California Fire Code Adopted.

Those codes known as the "California Fire Code," 2016 Edition, including Appendix Chapter 4, Appendixes A, B, C, D, H, I, J, and N with necessary California amendments and standards, also known or referred to as the 2013 2016 California Fire Code of the California Code of Regulations, Title 24, Part 9, which are promulgated and published by the International Code Council, 4051 West Flossmoor Road, Country Club Hill, IL 60478, are hereby adopted and made a part of this Chapter by reference with the same force and effect as if fully set forth herein, except such provisions as are hereinafter added, deleted or amended.

ACTION: Motion/Second: Osborne/Starbuck. By a 5-0 vote Council introduced, by reading of the title only, and waiving further reading, Ordinance Nos. 1632(17) and 1633(17), with the stated correction to Ordinance No. 1632(17), to adopt by reference, as required by State law, the 2016 California Fire Code and California Building Codes with amendments, as part of the Lompoc Municipal Code and set a public hearing on March 21, 2017, for adoption of the California Fire Code and California Building Codes, by reference.
