

RESOLUTION NO. 6128(17)

**A Resolution of the Council of the City of Lompoc,
County of Santa Barbara, State of California,
Suspending Increases in the
Monthly Water Service Consumption Charges**

WHEREAS, on August 6, 2013, the City Council adopted Resolution No. 5859(13) establishing fees and charges for the City's Water System; and

WHEREAS, at its meeting of May 16, 2017, after considering the impacts the 15% increase in monthly water service and user charges established by Resolution No. 5859(13) would have on many rate payers, considering their economic situations, the City Council decided to indefinitely suspend any further increases, leaving those charges at the same levels as those adopted by Resolution No. 6052(16).

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVES AS FOLLOWS:

SECTION 1: Effective July 1, 2017, the City Council hereby suspends collection of the July 1, 2017, 15% increase in monthly water service charges to the City of Lompoc's water service customers, other than those with express contracts with the City for Water Utility for service.

SECTION 2: Based on the above, the "Effective 7/1/2017" column in the table of water service charges for each metered premises, which are dependent on the meter size, as set forth on Page 3, Section 2A of Resolution No. 5859(13), is amended to read as follows to reflect the suspension set forth in Section 1, above:

SECTION 3: Based on the above, the "Effective 7/1/2017" column in the table of water use charges, which are based on the amount of metered water used per hundred cubic feet (HCF), or portion thereof, as set forth on Page 3, Section 2B of Resolution No. 5859(13), is amended to read as follows to reflect the suspension set forth in Section 1, above:

SECTION 4: The City Council reserves the authority to rescind the suspensions established hereunder at any time it determines necessary and those suspensions shall not affect the water service charges established by Resolution No. 5859(13).

SECTION 5: Except as expressly provided herein, all the terms and provisions of Resolution No. 5859(13) remain in full force and effect.
